- Haul Out, Pressure Clean the Bottom and Storage Only:** \$38 per foot / Slip holders \$33.00 per foot
- Core Winterization Service:** Check freshwater cooling to safe -30 degrees. Change oil and filter. Change fuel filters and bleed system. Winterize head, holding tank. Drain water system, drain hot water heater. Antifreeze water system, including all sinks, showers, cockpit shower. Antifreeze shower sumps, bilge, and sink drains. Run antifreeze through engine, fog engine if gasoline. Includes 1 head \$500 Additional head \$75 Each
- Sailboat Engine Winterization Service:** Check freshwater cooling to safe -30 degrees. Change oil and filter. Change fuel filters and bleed system. Run antifreeze through engine, fog engine if gasoline. \$280
- Inboard Engine Winterization Service:** Check freshwater cooling to safe -30 degrees. Run antifreeze through engine, fog engine if gasoline. \$150 2 Engines \$250
- Inboard/Outboard Winterization Service:** Check freshwater cooling safe to -30 degrees. Change engine oil and filter. Change fuel filters. Add fuel conditioner. Drain block and exhaust manifolds. Pull drain plug, reinstall if indoor storage. Run antifreeze through engine, fog engine. Change lower unit oil and grease fittings. \$300 per engine
- Outboard Engine Winterization:** Run fuel out of engine and fog. Add fuel conditioner to tank. Change lower unit lube. 2 stroke \$100 / 4 stroke \$75
- Generator Winterization Service:** Check freshwater cooling to safe -30 degrees. Change oil and filter. Change fuel filters and bleed system. Run antifreeze through generator, fog if gasoline. \$275
- Air Conditioning Winterization:** Drain water, blow unit dry, antifreeze if necessary. 1 unit \$90 Each additional unit \$40
- Hot and Cold Water System Winterization:** Drain water system, drain water heater. Antifreeze water system, including all sinks, showers and cockpit shower. Winterize heater. Antifreeze shower sumps, bilge, icebox and sink drains. \$240
- Washdown Water System Winterization:** Drain water, run antifreeze through. \$80
- Head and Holding Tank Winterization:** Pump out holding tank. Winterize head, holding tank, macerator and/or manual pump. \$135
- Remove and Fold Sail:** Remove sail, fold up. Store on board boat. \$125
- Deliver to In House Sail Repair/Starbird Canvas and Sails.** N/C
- Unstep Mast:** \$89/hr plus crane charge of \$75.00/hr
- Shrink Wrap Boat:** \$15.00 per foot up to 21 ft. \$17 per ft up to 30 ft. cruiser. Add \$3.00 for fly bridge. 32 foot plus quote. Sailboats add \$3.00 a foot

I hereby authorize the above work and the furnishing of the necessary materials and grant Havre de Grace Marine Center LLC and/or its employees permission to operate the above boat and or its equipment for the purposes of testing, inspection, or delivering. I agree that any hauling, towing, inspecting, or moving be at my own risk and that Havre de Grace Marine Center LLC is not responsible for loss or damage in case of wind, flood, freezing, fire, theft, or any other cause beyond its control. All facilities are offered with the understanding that Havre de Grace Marine Center LLC assumes no liability for damages to persons, or property and boat owners must carry insurance, a copy of which is on file with Havre de Grace Marine Center LLC along with a copy of a current MD title and registration for USCG documentation. The Marina reserves the right, at its sole discretion to reassign, move, or transfer the boat from slip to slip. Subleasing of slips or transferring boats between slips is not allowed except by the Marina. Only one registered vessel per slip. The Marina reserves the right to rent the slip whenever vacant and all revenues received from such rental shall inhere to the Marina. The Marina may terminate the license agreement for any reason (with or without cause) upon written notice to the owner. All winter storage bills must be paid by October 25. All billings not paid within 30 days shall bear interest at the rate of 2% per month. An express lien is hereby granted on the above boat to secure the amount of repairs, storage and other charges. If collection proceedings are necessary I hereby agree to pay any and all associated expenses. I have read and fully understand this agreement and the rules and regulations of the Marina and have provided to the Marina a list of all persons authorized to board my boat when I am not present. This agreement is not transferable or assigned in any way without the express written consent of the Marina. I warrant and represent that the vessel shall be maintained in a safe and seaworthy condition at all times during the term of this agreement and that the boat complies in all respects with Federal Water Pollution acts prohibiting the discharge of oily water and untreated sewage, as well as other applicable Federal and State laws and regulations. This agreement is assignable to property lien holders in the event of default by property owner.
